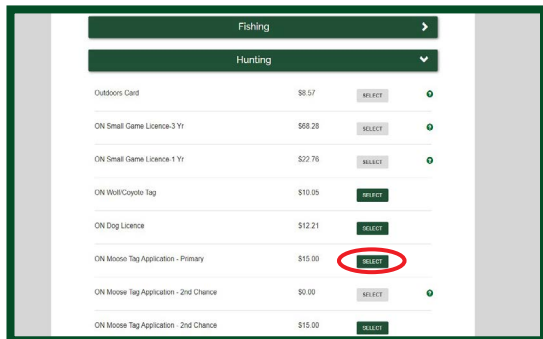


How to apply to the moose tag allocation from your online account

You can apply to the moose allocation online, by phone (1-800-288-1155), at a licence issuer or participating ServiceOntario location.

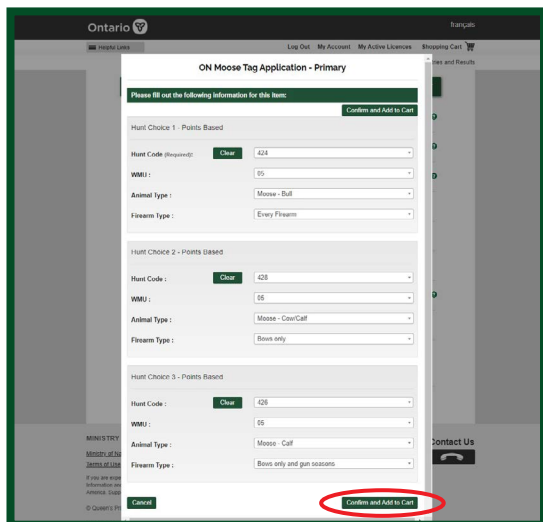
Get ready to apply. View moose tag quotas online beginning April 1. Remaining tags available for the Second Chance Allocation will be published online June 15. For information on how to find your point total review the [How to view your moose points tip sheet](#).



Applying to the Primary Allocation (April 1 to April 30)

Step 1

Visit www.huntandfishontario.com and select **“Buy Licences and Enter Draws,”** then login to your online account. If you haven't already set up your online account, please reference the [How to create an online account tip sheet](#).

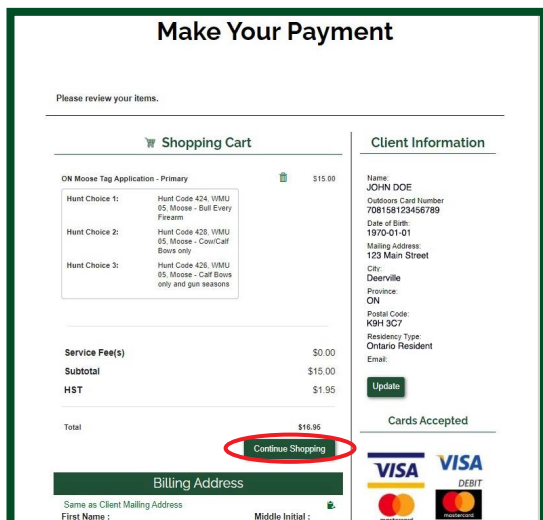


Once logged into your account, select **“Hunting,”** then **“select”** ON Moose Primary Tag Application – Primary.

Step 2

Choose your preferred hunt choice from the dropdown menu “Hunt Choice 1” (a second and third hunt choice is optional). You must select **“Confirm and Add to Cart,”** to ensure your application to enter the Primary Moose Tag Allocation has been added to the shopping cart then select **“Checkout”** to complete your transaction.

If you do not wish to claim a tag this year, but want to gain a point for the future, you can apply to WMU 99Z as your first Hunt Choice.



Step 3

Confirm your hunt choices are correct and enter your credit card information. Next, read the attestation and select the **“check box”** to certify your information is true. Finally, select **“Complete Transaction.”** Once your transaction is complete, your sales receipt will automatically be sent to the email address on file. Please review, print and save your sales receipt listing your hunt choices.

Applying to the moose tag allocation process does not permit you to hunt moose. All moose hunters must have a moose licence and hold a valid tag or be party hunting with a tag holder.

Applying to the Second Chance Allocation (June 15 to July 8)

If you were unsuccessful, didn't apply to, or claim a tag in the Primary Allocation, you can apply to the Second Chance Allocation. You **MUST** submit a new application to the Second Chance allocation.

The remaining moose tag quotas will be available online and by phone (1-800-288-1155) on June 15.

Step 1

Visit www.huntandfishontario.com and select **"Buy Licences and Enter Draws,"** then login to your online account.

Once logged into your account, select **"Hunting,"** then **"select"** ON Moose Tag Application – 2nd Chance.

Step 2

Choose your preferred hunt choice from the dropdown menu "Hunt Choice 1" (a second and third hunt choice is optional). You must select **"Confirm and Add to Cart,"** to ensure your application to enter the Second Chance Moose Tag Allocation has been added to the shopping cart then select **"Checkout"** to complete your transaction.

Step 3

Review your shopping cart to confirm your hunt choices are correct. If you did not apply for the Primary Allocation, enter your credit card information to pay the \$15 application fee. If you applied to the Primary Allocation, proceed to the bottom of the screen to complete transaction.

Next, read the attestation and select the **"check box"** to certify your information is true. Finally, select **"Complete Transaction."** Once your transaction is complete, your sales receipt will automatically be sent to the email address on file. Please review, print and save your sales receipt listing your hunt choices.

If you are awarded a tag in the Primary or Second Chance Allocation, you can claim your tag by purchasing a moose licence and your tag. For more information view the **How to claim your tag** tip sheet.

Your tag will be available to print starting the third Tuesday in August.
