Fisheries Management Zone(s) replace the former Fishing Divisions and are the geographic basis for managing, monitoring, assessing and regulating recreational fisheries for a majority of lakes and streams in a zone. Each zone is based on angler usage and ecological/geographic patterns such as climate zones, watersheds and road networks.

Description:

Spatial Multi-Tessellating-Polygon: An object is represented by ONE or MORE polygons. Polygons may NOT overlap. ALL features in the data class MUST be classified, meaning that HOLES, GAPS or OVERLAPS are NOT allowed. Example: "Fisheries Management Zone" data class. All land is accounted for and categorized. One zone may be made up of several parcels of land separated by other zones.

FISHERIES_MANAGEMENT_ZONE_FT

A Fisheries Management Zone is an administrative boundary that is officially filed with the Ontario Surveyor General (OSG) and has associated fishing regulations under the federal Fisheries Act. Fisheries Management Zone(s) (FMZs) (formerly called Fishing Divisions) are the geographic basis for setting fishing regulations such as catch limits and seasons. Each zone boundary is based on angler usage and ecological/geographic patterns such as climate zones, watersheds and road networks. The numbering sequence of zones has been standardized and the new zones are a combination of old division boundaries and new boundaries. The Fisheries Management Zone will become the unit of management for the majority of lakes so that fish populations are monitored, assessed and regulated at the zone level.
